



**DISTRICT OF HUDSON'S HOPE
LOAN AUTHORIZATION BYLAW
BYLAW NO. 974, 2026**

A Bylaw to authorize the borrowing for the construction of a Multi-Use Gathering Center.

WHEREAS Council may, by bylaw, with the approval of the Inspector of Municipalities, borrow funds for any purpose of a capital nature;

AND WHEREAS Council considers it desirable and in the public interest to construct a Multi-Use Gathering Center;

AND WHEREAS the estimated cost of constructing the Multi-Use Gathering Center is \$34,264,800, of which the sum of \$10,000,000 is the amount proposed to be borrowed;

NOW THEREFORE the Council of the District of Hudson's Hope, in open meeting assembled, enacts as follows:

GENERAL PROVISIONS

1. This Bylaw shall be cited as the District of Hudson's Hope "Multi Use Gathering Center Loan Authorization Bylaw No. 974, 2026".
2. If any provision of the bylaw is declared invalid by a court, the invalid portion shall be severed, and the remainder of this bylaw shall remain in effect.
3. The District of Hudson's Hope is hereby empowered and authorized to undertake and carry out or cause to be carried out the construction of the Multi Use Gathering Center in accordance with general plans on file in the municipal office and to do all things necessary in connection therewith and without limiting the generality of the foregoing:
 - a. To borrow upon the credit of the Municipality a sum not exceeding \$10,000,000, and
 - b. To acquire all such real property, easements, rights-of-way, licenses, rights, or authorities as may be requisite or desirable for or in connection with constructing the Multi Use Gathering Center.
3. The maximum term for which debentures may be issued to secure the debt created by this bylaw is 20 years.

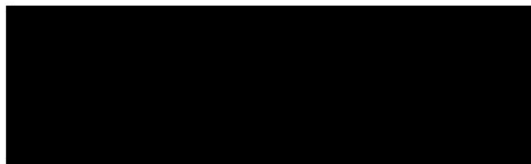
