Operational Issues:

Detachment Clerk Position: A Clerk was hired August and unfortunately the Clerk's Spouse is being transferred to another location in BC. Clerk Position will be vacant again after Oct 9, 2015. We are fortunate though that the hiring process was to remain open for a full year after the initial hire just in case for circumstances like this. We are now moving to the next applicant and will proceed with our security checks. We are hoping that we will have another Clerk hired by Dec this year.

Member Resources: Cst MCKENNA had arrived on Aug 15, 2015 and has jumped right into the mix at the detachment. Cst MCKENNA and his wife are happy to come to our community.

Hudson's Hope now has 2 members trained to operate the detachment jet boat on the river, but unfortunately during the training held locally, the boat took a bad hull rock strike and cracked the Jet water intake housing. The jet boat has been sent down to Vernon for repairs.

The first of three new police vehicles has arrived and has already been put into service.

Community Involvement:

Members have been attending the Hudson's Hope School since school started Sept 8. Members have attended most community events either on duty or off duty.

Other:

Members have engaged in speed enforcement campaigns in the following areas; Beattie Drive School zone, Canyon Drive, Beryl Prairie and Highway 29 near Halfway River. This will soon include Ferrell Creek Rd. Future enforcement campaigns to include seatbelts and stop signs.

Members are also setting up random drinking driving counter attack roadblocks throughout the community.

Community education will continue through the Hudson's Hope newsletter for topics such as, Child car seat requirements, taking steps to protect your residence from Break and Enter, vandalism, theft from vehicles and vehicle thefts. Three stolen vehicles from other communities have been recovered within the district of Hudson's Hope since August this year.

Members will continue to work to be proactive and visible within the community.

FRAUD AWARENESS

Tip #1

If you are not a customer of the company that appears to be sending you an email, ignore it. Fraudsters rely on the few recipients who are customers of the company to fall victim to the scam.

Tip #2

Even if you are a customer, never respond directly to an email request from a company for personal or financial information.

Instead verify the authenticity of the request by using an email or telephone contact that you know is legitimate.

Tip #3

Never go to a web site from a link in an email.

Instead open up a new browser window and enter URLs that you know are legitimate directly into your browser. Better yet, use bookmarks you created.

Tip #4

Check your credit card and bank statements immediately after receipt.

Look for charges or transactions that you don't expect; even small ones can be a sign of trouble.

Tip #5

If you unwittingly supply personal or financial information, inform the appropriate institutions immediately. Banks and credit card companies will work with you to prevent your information from being used against you.

Tip #6

Become familiar with the tricks of the trade so you can spot fraudulent emails.

Knowledge is a powerful weapon in the fight against email fraudsters.

Tip #7

Stay up to date.

Make sure your operating system and critical security software applications – such as anti-spam, anti-phishing, anti-virus and anti-spyware are current.

Police Report – September 2015

Over the last month, Hudson's Hope RCMP Detachment responded to approximately 45 calls for service. Hudson's Hope RCMP members continued with traffic enforcement throughout the area and conducted check stops in an effort to target impaired drivers. Some incidents of note during the month are as follows:

On August 27th, 2015, Hudson's Hope RCMP received multiple calls regarding a grizzly bear in town. Police made patrols throughout the area, notifying residents of the danger and were eventually called to a residential property as the bear had chased a resident. The bear remained on the property and had to be dispatched by police due to its aggression toward humans. Other bear sightings have also been reported to police throughout the month and we have worked with BC Conservation officers to address each call. The RCMP recommend residents become bear aware by visiting http://www.env.gov.bc.ca/cos/info/bearaware/prevent_problems.html

Aggressive wildlife in rural areas can be reported directly to BC Conservation Officers 24 hours a day, toll free, at 1-877-952-7277 and by calling your local detachment or 911 in emergency situations.

On September 10th, 2015, Hudson's Hope RCMP was advised of an attempted fraud at a local business. The fraudster identified himself as an employee of the Canada Revenue Agency and threatened that legal action and a warrant for arrest would be issued for overdue files. This type of fraudulent call is becoming more common and personal information should never be shared with an unknown person.

On September 16th, 2015, The Hudson's Hope RCMP hosted the Cops for Cancer Tour De North riders as they passed through the area and visited the school. The Hudson's Hope RCMP wishes to extend appreciation to the Lions Club and to Country Favours Catering for their assistance in making the event a success. On September 18th, 2015, around 8:00 P.M., the Hudson's Hope RCMP responded to a single vehicle collision near Farrell Creek involving a stolen vehicle. The suspect had fled the scene prior to police arrival and may have been picked up in the area. Police Report – August 2015

Over the last month, Hudson's Hope RCMP Detachment responded to approximately 41 calls for service. Hudson's Hope RCMP members continued with traffic enforcement efforts throughout the area and issued several violation tickets and written warnings to drivers.

Some incidents of note during the month are as follows:

On August 4th, 2015, Hudson's Hope RCMP was alerted to a stolen vehicle in Fort St. John that may be heading into Hudson's Hope. The vehicle was subsequently located and a male occupant of that vehicle was arrested. Police have recommended three charges against the male who is scheduled to appear in court in September.

On August 5th, 2015, Hudson's Hope RCMP was advised of a break and enter and theft at the local YRB yard near Hudson's Hope. Police responded and obtained statements from employees who detailed the break in and theft of a YRB vehicle and other items inside. Fort St John RCMP Forensic Identification Service was called to assist in processing the scene. The YRB vehicle was located later in the morning and police are continuing to investigate the incident.

On August 11th, 2015, Hudson's Hope RCMP responded to an ATV collision on private property near Farrell Creek Road. The female driver of that ATV had succumbed to serious injuries sustained from the collision. An RCMP Traffic Analyst and BC Coroner Service were called to the scene to assist investigators with the ongoing investigation.

On August 17th, 2015, Hudson's Hope RCMP was advised of a vehicle on fire on Canyon Drive at the pullout near Beryl Prairie Road. A commercial dump truck was engulfed in flames when police arrived at the scene. The cause of the fire is unknown at this time.

On August 21st, 2015, Hudson's Hope RCMP was advised of an active brush fire near Halfway River that was approaching the Highway. Police alerted local fire officials and the Ministry of Forests. Hudson's Hope RCMP would like to recognize the efforts of local volunteers who assisted in quickly gaining control of the fire and prevented it from reaching forested areas. The file remains under investigation to speak with possible witnesses.

BACK TO SCHOOL

Hudson's Hope RCMP would like to remind drivers to be vigilant of pedestrians, especially young school students, who will be walking along and crossing local roads and streets during the upcoming school year.

The Hudson's Hope RCMP will be strictly enforcing road safety on all roads and school zones in an effort to educate drivers and maintain safety for pedestrians.

Parents are encouraged to discuss road safety with their children. Some basic tips are as follows:

- **Look** left-right-left and shoulder check before crossing.
- Make eye contact with drivers and keep looking for approaching vehicles while crossing.
- **Listen.** Remove your headphones so you can hear approaching traffic that may be hard to see.
- **Be seen.** Wear reflective materials or bright clothes and use lights after dark.
- Walk on the inside edge of the sidewalk away from the road. If there's **no sidewalk** - walk facing oncoming traffic, so you can see approaching vehicles.
- **Never jaywalk.** Be extra cautious at intersections. Watch for vehicles turning left or right through the crosswalk.

BYLAW NO. 852, 2015

A Bylaw to amend the Campgrounds and Community Recreation Facilities Fee Amendment Bylaw No. 746, 2008

WHEREAS pursuant to Section 194 of the *Community Charter*, Council may, by bylaw impose a fees and charges payable in respect of any service it considers necessary or desirable;

AND WHEREAS Council deems it necessary and desirable to exercise the authority provided by the *Local Government Act* to cover costs or providing various services and information;

RE: Socio-Economic Effects Management Plan Update – September 15, 2015

As a follow-up to our June 5 letter, which accompanied PRGT's Draft Socio-Economic Effects Management Plan (SEEMP), PRGT would like to give all local governments, service providers, Aboriginal groups and the Nisga'a Nation an update on the development of the SEEMP and next steps.

Thank you to those who have submitted comments on the Draft SEEMP. Your comments will not only inform this plan, but will also shape the information we share, the way we share it and how we report on and monitor socio-economic effects. We are in the process of reviewing and responding to all comments and making necessary adjustments to the SEEMP. Much of the feedback received highlighted a desire for more details on local construction plans and local mitigations. These details will be shared as part of ongoing engagement on the SEEMP and continue throughout the course of construction. As the pipeline construction contractors are brought onboard, detailed planning will be developed and this information will be shared with affected local governments, service providers, Aboriginal groups and the Nisga'a Nation. In the coming weeks, we will follow up with all who have provided comments to discuss the issues and comments brought forward and identify engagement activities that may be helpful in dealing with topics that fall outside of the scope of the SEEMP.

For those who have not submitted comments on the SEEMP, we continue to welcome feedback and **request that comments be submitted to PRGT on or before September 30, 2015.** Feedback received by that date will be given consideration and reflected where appropriate in the submission made to the Ministry of Community Sport and Cultural Development and the Environmental Assessment Office for approval of the SEEMP.



Protect your health by getting immunized

A pertussis (whooping cough) outbreak has been declared by local health authorities in northern Alberta and in parts of Saskatchewan. As we are seeing an expected seasonal increase of pertussis in northern B.C., Northern Health recommends residents ensure they are up to date for routine immunizations, including pertussis.

You may have heard lots of conversation in the media lately about vaccine preventable diseases such as measles, mumps, and whooping cough (pertussis) cases. Fortunately, due to vaccination most of us have never seen these diseases and their devastating effects. This is because vaccines have been very effective in helping control the spread of these diseases. Vaccines have saved more lives in Canada than any other medical intervention in the past 50 years.

In reality these diseases haven't disappeared and if immunization rates drop or we stop immunizing the diseases will come back. In many cases these diseases are just a plane ride away. For example in 2014, the Fraser Valley experienced a measles outbreak of over 400 cases. The outbreak was linked to a family returning from a trip overseas where a child was infected with measles. At any age, vaccination provides long lasting, effective protection against disease.

Immunizations don't just protect you; they protect everyone around you too! Certain groups of people are unable to be immunized because they are too young or they may not be able to receive vaccinations due to illness or a weakened immune system. Some vaccines work by creating "herd immunity," which is when most people in a community have received a vaccine for a particular disease, the chance of an outbreak of that disease is greatly reduced. Getting vaccinated helps prevent the spread of these diseases to your friends and loved ones.

Dear Premier Clark:

I am writing to ask that you have a two year moratorium on the construction and development of the Site C Dam and that the proposed project be referred to the British Columbia Utilities Commission (BCUC) for review and consultation.

As a community that has experienced the effects of a dam, we are very concerned that the government of BC would consider making the same mistake again. The destruction of a valley for power that is questionably in need cannot be justified. The village of Nakusp and the communities of the valley have suffered economically, as well as environmentally and we continue to suffer yearly as we experience the vagaries of weather and the decision to generate power over the concerns for the environment and the people. Large dams are not the answer.

We believe that there should be a moratorium and an open, independent and expert review by the BCUC with full procedural safeguards. We now understand that a large number of municipalities in BC have signed on to this initiative which is in keeping with recommendations from the 2014 Environmental Assessment Federal/Provincial Joint Review Panel Report.

Beyond deep concerns regarding the destruction of a key food producing area we would like to stress that we understand that there are questions about infringement of treaty rights and that the damage to the environment, including shore birds cannot be underestimated. Our concerns are also heightened by the following:

- Electricity rates will have to increase to pay for it when lower cost options are available
- Borrowing of \$8.8 billion will affect capacity to build other major projects
- BC Hydro's already sizeable debt will increase
- Proper procedural approval processes have been circumvented

Please also support a vote in favour of a moratorium and BCUC review at the upcoming September 21-25 meeting of the Union of BC Municipalities.

We hope your community enjoyed an outstanding summer season! I would like to thank you and your team for your continued contribution to growing the tourism industry in British Columbia.

As you know, Destination BC has conducted extensive research, reviewed our programs, and gathered community feedback in support of the development of a new strategic direction for Visitor Services. This plan will respond to evolving consumer trip planning trends and will modernize the way we support the delivery of visitor services around the province. Our goal is to enable a more flexible, innovative, community-based visitor services model.

During our robust consultation process earlier this year, conducted in 20 communities across the province, your input was sought on how to evolve the Visitor Services Network. A number of topics were explored, including the funding model for visitor services. Based on consultation feedback, we were advised the current Fee for Service model presents a challenge for your budgeting process. 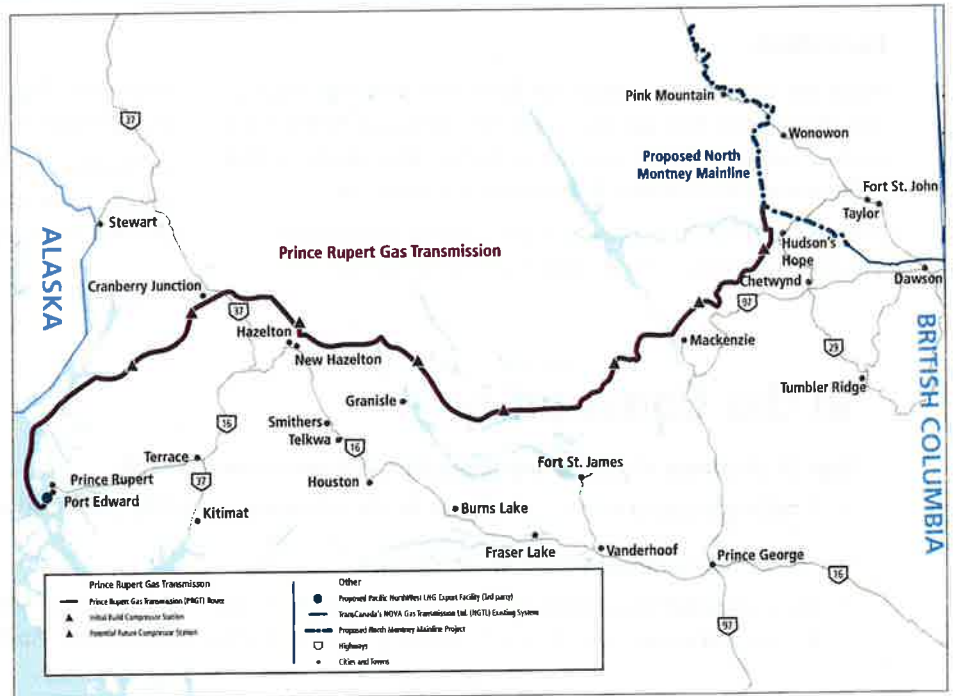

PRGT Project Activity Update #28

About the Project

The proposed Prince Rupert Gas Transmission (PRGT) Project is an approximately 900 kilometre natural gas pipeline to be routed from north of Hudson's Hope B.C. to the proposed Pacific NorthWest LNG export facility on Lelu Island within the District of Port Edward. Upon receiving all approvals, PRGT will be constructed and operated with safety and environmental stewardship as top priorities.

Once it's operating, the project will generate an estimated \$25 million each year in property taxes. This revenue will help support school and hospital districts, emergency services, recreation services, recycling programs and other local programs vital to sustaining strong communities.



Project Updates

PRGT continues to progress project development activities, including engagement with community and Aboriginal groups in preparation for the commencement of pipeline construction activities. The start date of this construction activity is dependent on PRGT's receipt of all required permits and is aligned with Pacific NorthWest LNG's (PNW LNG) federal regulatory approvals. It is also dependent on PNW LNG making a final decision to proceed.

Once these approvals have been granted, PRGT will begin site preparation at camp locations and other ancillary sites. Following this initial construction activity, right-of-way clearing would begin with commencement of pipeline construction activities shortly thereafter.

Over the coming months, PRGT will be directly engaging with Aboriginal groups, communities, and businesses to share information about opportunities in advance of pipeline construction activities.

Regulatory Update

Since the beginning of May, PRGT has received construction permits from the BC Oil and Gas Commission (BC OGC). The permits include conditions related to notification and reporting, heritage conservation, First Nations engagement, land clearing, wildlife, terrain stability, stream crossings, and engineering. To date, PRGT has received four pipeline construction permits from the OGC, which represent approval for construction work stretching from the eastern end of the route near Hudson's Hope to just north of Hazelton, as well as two compressor station permits. In total, TransCanada has applied for 11 pipeline and facilities permits from the BC OGC and anticipates a decision on the remaining permits in the coming weeks.

In addition to permits required from the BC OGC, PRGT has started to secure Temporary Use Permits, where necessary, related to the project's camp, stockpile, and laydown sites from Regional Districts and municipalities across the route. We will continue to engage and work with these stakeholders to ensure all conditions of the permits are met as we move into construction.

PRGT Project Activity Update #28

Field Work

Project field crews have now begun site assessment work in the Nisga'a area. This particular work will help to determine the suitability of selected mix bury cover sites. Geotechnical work in the Nass area has also recently started and will be undertaken to investigate area camp sites.

With respect to environmental field work, several field programs including archeology, fisheries, and vegetation studies are still

active. PRGT has also commenced our field flagging program for environmental features along the right of way and at ancillary sites.

Mackenzie Nature Observatory Bird Banding Station

For the third year, PRGT staff volunteered at the Mackenzie Nature Observatory (MNO) Bird Banding Station at Mugaha Marsh. This record-breaking year saw three banders and many new and returning volunteers out at the site to collect valuable data on migratory birds in the area such as the Ruby Crowned Kinglet, American Redstart, and Orange Crowned Warbler. As the new birds were banded, information

such as weight, wing length, fat, moult, age, and gender was collected, while returning birds were recorded against their last collected data. The day we were at the site, banders broke the previous record of 610 Ruby-Crowned Warbler recorded in a year by collecting information on this year's 612th. Thank you to MNO for inviting us to be a part of this important initiative!

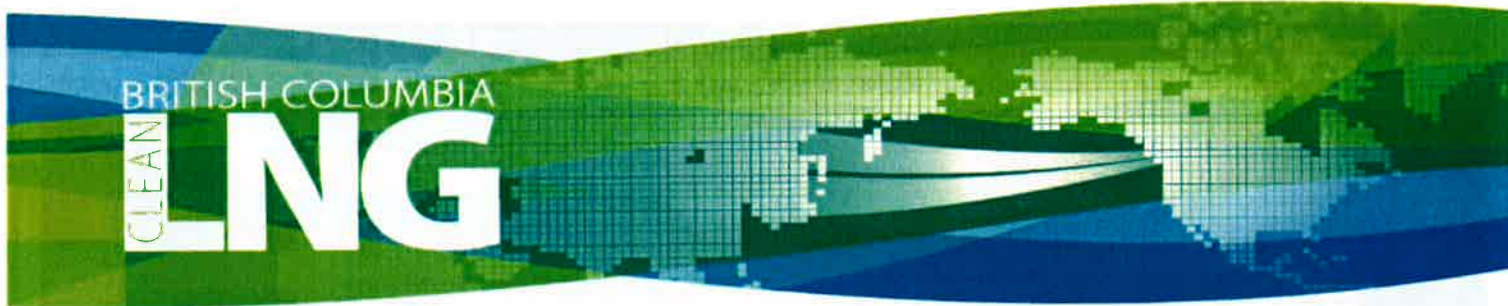

Good afternoon,

I am writing to notify you that Coastal GasLink Pipeline Ltd. (Coastal GasLink) is taking steps to apply for an alternate route in the Morice River area by amending our Environmental Assessment Certificate (EAC) that we received from the BC Environmental Assessment Office (EAO), and our BC Oil and Gas Commission (OGC) permit.

The proposed alternate pipeline route is located in the Regional District of Bulkley-Nechako. It begins at a point approximately 35 kilometres south of Houston and runs westward, approximately parallel to our EAC route. Most of the alternate route is on the north side of the Morice River rather than the south side. It rejoins the EAC route approximately 56 kilometres from its starting point. See attached map for further reference.

The decision to submit this application follows extensive consultation with Aboriginal groups in the area who expressed a concern about pipeline construction activities south of the Morice River, and the potential effect to the underground springs that feed the River. We are now considering the feasibility of an alternate route referred to as the "Morice River North Alternate" (MRNA) route which is approximately five kilometers north of our current pipeline route. Environmental, archaeological and engineering information has been collected on the MRNA route that would support amendment applications to both the EAO and OGC. Aboriginal groups whose traditional territory may be potentially impacted by the proposed MRNA route were invited to participate in the field data collection programs and provide Traditional Ecological Knowledge.

We anticipate filing an application to amend the EAC with the EAO as early as November 2015, and applying to the OGC for approval of the MRNA route shortly after. The final route will be determined as an outcome of these regulatory processes, and once we have had the opportunity to advance construction planning and detailed engineering design taking into account cultural, environmental, commercial, and constructability considerations.

Good morning Ken and Robin:

I met with Hudson Hope representatives yesterday at UBCM. They have undertaken some preliminary testing related to elevated metals in the Lynx Creek/Brenot Creek area. The results can partly be ascribed to the recent landslides in the area but they are looking for some help to complete further testing to ensure that this is an isolated metals peak and that there are not broader water quality issues at play. This seems to be a small project that could be done quickly.

I suggested they connect with you and that perhaps Allan Chapman, one of our MoE water quality scientists and someone from GeoScience BC could meet with the Mayor and CAO on how community concerns could be addressed. I'm happy to volunteer one of our staff's time to help out with this if this would help.
