- Rural and Northern Communities fund; for communities with 5,000 residents or less combined Provincial and Federal funding will cover 100% toward eligible costs; funding to be used towards a wide range of infrastructure priorities including broadband connectivity, efficient and reliable energy, Indigenous health and educational facilities, local public transit and reliable road, air an marine infrastructure, as well as improved resilience to natural disasters and environmental quality.

## 12. REPORTS BY MAYOR & COUNCIL ON MEETINGS AND LIAISON RESPONSIBILITIES

#### CR1 Mayor's Report to Council

- I Municipal Election:
  - Congratulations to Councillor Heiberg on being acclaimed as the next Mayor of Hudson's Hope. Thanks to all the incumbents who submitted your nomination papers to continue on Council and also to the four non-incumbents.

- Best Wishes to all during the election.
- II Northern Development Initiatives (NDI) Trust:
  - Housing:
    - NDI is researching housing as an issue, (Age & Adequacy of Housing in the North).
    - They found that single, detached, fairly small houses are in demand.
    - 10 -15% of housing stock is in poor repaid.
    - Many northern municipalities have needs.
    - Staff will bring forward a policy for a new basket of funding to be used for housing.
    - NDI policy must conform to terms of reference, which is economic growth; therefore NDI will be able to assist with housing when lack of housing is a barrier to economic growth.
    - This should help the Seniors Housing Project need to frame the request as an economic issue.
       (Seniors are significant portion of HH population & facilitating their housing enables them to stay in the community, where they contribute to the local economy; expansion of the seniors housing will create jobs during construction and small number during operation (book-keeping, maintenance, meal preparation etc).
  - Peace River Legacy Fund: Presentation (Also called "Site C Continuation Measure")
    - Joel (Staff) provided background, saying that, "NDI was contacted by Ministry of Energy, Mines and Petroleum Resources (MEMPR) asking to do a presentation." 'This is not (NDI) Trust business, it's just for information.'
    - This is a MEMPR initiative & they are working with Tammy Danshin, Economic Development & Dale Morgan, Ministry of Indigenous Relations and Reconciliation.
    - This was the first presentation they have done.
    - Done by conference call. We have a copy of the PowerPoint.
    - Presenters were Ellen Frisch (TJC Consulting) & Catherine Rowe, MEMPR Director of Electricity.
      - this is a new initiative.
      - Money is sourced from the water licence fees paid to the province.
      - Nothing is pre-determined by the province.
      - Money flows when the dam goes on-line.
      - First step is to look at options for organization.
      - In 2019, Cabinet will decide on the option to be chosen. (eg Columbia Basin Trust model (favored by Minister Mungall), NDI model, etc).
      - They will be coming to the region to "consult." Originally Oct 30 - Nov 7 & Nov

- 26-30 but now pushed into 2019 to give new councils time to get up to speed.
- Consultation will be in 5 communities: Hudson's Hope, Chetwynd, Fort St John, Dawson Creek and Tumbler Ridge.
- The water licence fees will be split between three programs:
  - 1. This Peace River Legacy Fund.
  - 2. BC Food Security Program.
  - 3. Nations Clean Energy Program.
- Total dollars available is expected to be about \$40 million/ year.

#### • III UBCM Report:

#### o Awards:

 Hudson's Hope received two awards: Councillor Miller has a report on them.

#### Resolution:

- The Hudson's Hope resolution on Daylight Savings
   Time came up on Friday, very near the end, after
   the rest of the Hudson's Hope delegation had left.
- The Mayor did speak to it. It did pass with a 52.3% vote, although had to go to an electronic vote.
- Has generated more attention than a lot of other resolutions we have put forward.

#### Ambulance Service:

- Chetwynd put forward a resolution asking that the province initiate a full and in-depth review of ambulance service in BC.
- Resolution refers to rural communities, but some large urban centers spoke up as well, so the issue has broad interest.
- It was referred to the UBCM executive. That gives it a higher priority, hopefully. So maybe we will get something to happen now.
- CAO is following up on it to see how Hudson's Hope can be kept in the loop.

#### Rural Roads:

- The PRRD Rural Roads Committee met with Ministry of Transportation and Infrastructure (MOTi) Minister Trevena regarding the need for a rural roads upgrading program, emphasizing that resource extraction is hampered with poor road access.
- Presentation was done by Jackie Kjos, the consultant hired by the PRRD for this issue.
- She has a lot of background, having filled the same role when Rural Task Force #1 was active in the 1990's.
- She spent a lot of time talking about the Farrell Creek Hill., which is the #1 priority now. She explained the impact the Farrell slide is having on industry costs, efficiency etc. Beryl Prairie is second.

- She had previously met with Dave Nicoleejsin, Ministry of Energy, Mines and Petroleum Resources Deputy Minister, and he had appreciated her explanation a great deal. He helped get the appointment with the MOTi minister, and also referred her to his Assistant Deputy Minister of oil & gas, Inez Penicinni.
- The Farrell Creek Road is being paved now, from the top of the hill to about km 16, I believe.
- It was a good presentation and seemed wellreceived.
- The objective is to get The Minister and staff here to do a helicopter tour to see the issue.
- Not in presentation was the relationship between Farrell Creek Hill and the realignment of Hwy 29 in that section. Information from Hydro is that they intend to go out into the river rather than touch the Farrell Creek Hill, so no synergies there, unless instruction comes from government.
- Recent Development: Arc Resources has applied to construct a road up to their sub-surface (large contiguous block, highest priced sale in 2017). They would use the old Swanson Lumber Road this side of the Halfway River. Would be better for us if we could get 1 good road, rather than 2 poor ones going up the hill.
- There is an information meeting on Thursday to give people an update on what's happening with the road situation. 7pm at the Community Hall.

#### o Other:

- Geo-Science BC presentation made by Mayor Johansson had about 7 attendees.
- Water Ministry of Forests, Lands, Natural Resource Operations & Rural Development & Ministry of Environment - proposed a program to test Lynx Creek and gather information about risk to water should LNG go ahead.
- IV Landuse Planning Roundtable:
  - First meeting is this Wednesday 6:30-9:30.
  - Ministry of Indigenous Relations and Reconciliation is the sponsoring Ministry.
  - Contract for facilitating the process is TJC Consulting, the same as the Legacy Fund.
  - Ellen Frisch will be there on Wednesday & we have a tentative appointment with her prior to the meeting.
  - Meeting will talk about basic organization, structure, terms of reference, etc.

Good afternoon,

An application for the expansion of the Section 16 *Land Act* over the Dancing Grounds parcel submitted by the Ministry of Indigenous Relations and Reconciliation for Blueberry River First Nations' Treaty Land Entitlement claim, has been accepted by the Ministry of Forests, Lands, Natural Resource Operations & Rural Development, and has entered the review process.

Treaty Land Entitlement is a specific claim for a land debt owed to Treaty 8 First Nations, from the time of signing Treaty 8. Blueberry River First Nations did not receive all the land they were entitled to under the terms of the Treaty and this land debt is still outstanding more than 100 years later. The Treaty Land Entitlement settlement will right this historic wrong by providing the First Nations land they should have received under the Treaty.

Section 16 Land Act designations may be placed on Crown land as a means of preventing or restricting the disposition of the land due to an acknowledged value or concern — in this case for the purposes of Treaty Land Entitlement. Parcels receiving Land Act designations are still Crown lands and access remains open for activities such as hunting and fishing. The reserves also do not restrict existing tenure holders authorized under legislation outside of the Land Act.

As part of the review process of the proposed Section 16 *Land Act* designation, the application, map and shape files are posted to the Applications and Reasons for Decisions webpage. There you can also find a document that provides more background information on Treaty Land Entitlement, comments heard during previous stakeholder engagement, and a link to provide your comments on how the application may potentially impact your interests. I wanted to express my thank you for having the side by side on site for That Dam Run. That Dam Run has become an established annual event hosted by Hope for Health. It is gaining popularity on the regional running circuit. We have over 100 participants and approximately 25 volunteers that make this event a success.

One of our major concerns is the safety of our participants and volunteers. BC Hydro has been an incredible partner; they have not only allowed access to the WAC Bennett Dam crest but also closes the road for three hours; this means runners/walkers do not have to contend with any traffic. Huge benefit.

Another huge safety concern is for the trail runners and folks manning water stations on the trail. We do have a mobile ambulance on site, but they do not have access to the remote locations on the trail. We worry about possible injuries and, in our neck of the woods, the large critters that may be wandering around the area.

Having the volunteer Fire Department on site with their unit alleviates many concerns. It is a huge safety factor. Please pass on my thanks to Allen and Joe for volunteering their time to do this.

That Dam Run hosted by Hope for Health was a huge success because of your support. Thank you so much.

We are looking forward to hosting and partnering with you again for next year's That Dam Run, tentatively slated for September 22, 2019.

# Construction bulletin

#### Site C Construction Schedule: October 1 – October 14

#### Dam site area - north (left) bank and south (right) bank

- Contractors will continue to move equipment and material to site.
   This includes deliveries by rail.
- Contractors are continuing construction and operations in their work areas. This includes the main civil works, generating station and spillways civil works, turbines and generators, and substation.
- Water management activities may take place.
- Excavation, including in-river excavation, will progress on the north and south banks.
- Construction activities such as drilling, blasting, crushing, earth moving, tunnelling, concrete placement, and road maintenance will continue. Tower and mobile cranes will be used on site.
- Site preparation will continue at the 85th Avenue Industrial Lands.
   Work may begin to construct the conveyor that will connect to the dam site.

## Highway 29

- Site investigations, including geotechnical and archaeological investigations, drilling, studies, and survey work, will take place for Cache Creek/Bear Flat and the potential boat launch location. Minor brushing and danger tree removal may be needed.
- Some utility poles may be temporarily moved along Highway 29.
- Construction is expected to begin at Cache Creek West on the highway realignment. This will include site preparation, work at Peace View borrow area, clearing and grubbing, and the processing of aggregates.

#### Reservoir area

- Site investigations and collection of forestry and access road data will continue near and along the reservoir area.
- Clearing and debris disposal will take place in the lower reservoir and Moberly River area, as permitted by ground conditions and the fire

danger rating. Wood waste may be chipped, mulched, spread as coarse woody debris, hauled off site, or burned.

#### **Transmission works**

- Clearing may take place in areas along the transmission corridor, as permitted by ground conditions and the fire danger rating. Wood waste may be chipped, mulched, spread as coarse woody debris, hauled off site, or burned.
- Maintenance and upgrade work will continue on existing roads that provide access to parts of the transmission corridor. New road construction will continue within the transmission right-of-way.
- Material and equipment is being delivered to the marshalling yard in Moberly Lake.
- Site investigations, including stripping and data recovery of archaeological sites, geotechnical work, and structure staking, may take place along the transmission corridor. As part of ongoing field investigations, helical piles will be installed and tested.
- Upgrades will continue at Peace Canyon Generating Station, including work inside the switchyard building and outdoor foundation and electrical work.

#### Other areas

- Wildlife and aquatic mitigation programs will continue and may include surveys, data collection, habitat installations, and habitat enhancements.
- Surveys and visual inspections may take place for the noxious weed program in Site C project areas, including the 85th Avenue Industrial Lands, dam site, transmission line corridor, and Highway 29 realignment areas.
- Aggregate and riprap production will continue in West Pine Quarry.
   Material will be transported by rail and road to the dam site.

#### What to expect

Work will take place during the day, night, and on the weekend, until the project is completed. During this time, residents can expect the following:

- There will be project-related traffic on public and resource roads.
- Highway 29 may be reduced to single lane alternating traffic in certain places.
- Trucks with heavy loads will be accessing the dam site and other project areas. Please use caution when meeting a pilot car and observe all warning signs.
- Helicopters and commercial drones may be used to support investigative and construction works.

- Some noise and vibration may occur near the dam site and work areas, including the quarries.
- There may be smoke in various areas as a result of planned burning.
   Burning will only take place when permitted by the fire danger rating and when venting windows are available.
- For boater and worker safety, please stay clear of active in-river work areas along the Peace and Moberly rivers. These areas are clearly identified with signage and markings.

**Note:** In BC Hydro's technical documents, the north bank may be referred to as the left bank and the south bank may be referred to as the right bank.

### Re: Provincial Keep of Prisoners Program

In April 2018, the RCMP "E" Division provided formal notification to withdraw from the responsibilities of administrating the KOP program, effective October 1, 2018. As a result, the KOP program administration will transfer to BC Corrections.

BC Corrections will now be responsible for reimbursement to municipalities for the costs of maintaining provincial prisoners in local police detention facilities, which will include:

- receiving and processing quarterly billings from municipalities;
- distributing quarterly reimbursement payments to municipalities in accordance with the existing funding model; and
- reporting quarterly summary and statistical information to Policing and Security branches.

This administrative change will not change the amount of funding available to municipalities through the KOP program and the formula upon which municipalities are reimbursed through the KOP program are not affected by this new arrangement.

There are no changes related to maintaining federal prisoners in local police detention facilities.

Lastly, billings from municipalities for provincial prisoners should be submitted to the Ministry of Public Safety and Solicitor General, Corrections Branch beginning with the quarter ending September 30, 2018. Invoices should be directed via email to:
