



**DISTRICT OF HUDSON'S HOPE
BYLAW NO. 973, 2026**

A Bylaw to amend Fees and Charges Bylaw No. 915, 2020

WHEREAS Council has the authority to impose fees and charges in respect to any service Council considers necessary or desirable;

AND WHEREAS Council wishes to amend District of Hudson's Hope fees and Charges Bylaw No. 915, 2020;

NOW THEREFORE the Council of the District of Hudson's Hope, in an open meeting assembled, enacts as follows:

GENERAL PROVISIONS

- 1.1 This Bylaw shall be cited as "District of Hudson's Hope Fees and Charges Amendment Bylaw No. 973, 2026".
- 1.2 If any portion of this Bylaw is declared invalid by a court, the invalid portion shall be severed, and the remainder of the Bylaw is deemed valid.
- 1.3 The headings used in this Bylaw are for convenience only and do not form part of this Bylaw and are not to be used in the interpretation of this Bylaw.
- 1.4 Schedule E is attached to and forms part of this Bylaw.

AMENDMENT

- 2.1 District of Hudson's Hope Fees and Charges Bylaw No. 915, 2020 is amended as follows:
 - a. Replacing Schedule E – Cemetery Services Fees, with the attached Schedule E – Cemetery Service Fees.
