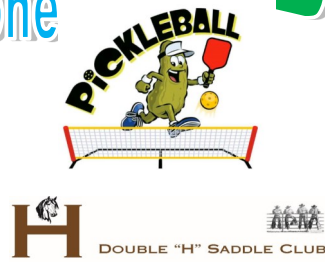

INTRODUCTION TO ENHANCED CARE

DISCUSSION GUIDE



Your insurance coverages now
covers **your own insurance needs**

Under Enhanced Care, we are **moving away** from third-party coverage and customers will have **more first-party coverage**. This change applies to how Basic insurance coverages respond to a claim.

With first-party coverage, Basic insurance pays for the customer's injury claims regardless if they caused the crash or not. If their vehicle is damaged and they're not at-fault, their Basic insurance will cover the vehicle damage too.

Introduction to **Enhanced Care**

Enhanced Care is a whole new way of doing auto insurance in B.C., one that **lowers the price of insurance** for drivers in our province but, importantly, also provides everyone with access to **significantly better care and recovery benefits** if they're injured in a crash.

By moving from an adversarial approach of suing an at-fault driver in today's system to a model where **each driver's own policy covers their claim**, the costs associated with our current litigation-based system will be dramatically lower.

Savings are passed on to the people of British Columbia through **more affordable** insurance rates, a savings of 20% on average.

Under **Basic Insurance**:

- 1 All British Columbians will have the same access to care regardless of who is responsible for the crash through their **Enhanced Accident Benefits**.
- 2 Damages to a customer's vehicle will be collected from their own policy up to the degree that they are not at-fault through **Basic Vehicle Damage coverage**.
- 3 Third Party Liability will still be important in certain circumstances, like driving out of province.



Basic Vehicle Damage coverage will pay to repair or replace a customer's vehicle up to the degree that a customer is not at-fault. For example, if a customer is **75%** at-fault, BVDC will pay for **25% of vehicle damage**, up to a limit that will be decided in regulation.

WATER TREATMENT PLANT UPGRADE

Inception of the project

As a result of the Site C dam project, the water level of the Peace River will rise by approximately 6.0m when it becomes a reservoir. As such, the existing river intake and pumping infrastructure will be submerged.

Consequently, either the river intake would need to be replaced, or a new water source would be required. The two options for a water source were a) using the existing river and spring water systems, or b) constructing a new groundwater source. As with every decision there are pros and cons and the following outlines some of main factors considered:

Existing River Source

Pros

- Residents are accustomed to the existing source.
- Existing treatment plant was expected to not require any modifications to continue using river water & spring water.

Cons

- Variable temperature and turbidity, but acceptable high-water quality
- Vulnerability to surface water and reservoir contamination. The water in the reservoir would not be moving as quickly as in the river, thus a greater degree of potential contamination.
- Unknown short-term effect on water quality during dam construction and river flooding.
- Water quality varies with the season.
- Due to flow rate changes, the level of turbidity in the reservoir is unclear, potentially putting additional stress on the water treatment plant.
- Surface water high turbidity requires specialized filter media to clean the water prior to disinfection.
- The river intake site is difficult to access, especially during the winter for operations and maintenance.

New Well Source

Pros

- No effect on the water quality during dam construction.
- The new water well will be located near the existing water treatment plant with easy access year-round.
- Water quality will not vary with the season. It will be consistent quality year-round.

Cons

- New source unknown to residents.
- Water must be treated to meet regulatory requirements and aesthetic objectives for physical properties.
- Existing treatment plant will require modifications to treat the deep well water.

After consultation with our Public Works Department, Engineering Consultant, and BC Hydro it was decided to drill a test well to explore the Aquifer Water source option. The water was tested for the parameters outlined in the Guidelines for Canadian Drinking Water Quality and Northern Health's Water Quality Objectives and it was found that three properties were above the allowable limits and two items were above the aesthetic objectives. Parameters above the maximum allowable concentrations are Barium, Methane, and Hydrogen Sulfide. The parameters that are above the aesthetic objectives are the Total Dissolved Solids and Manganese.

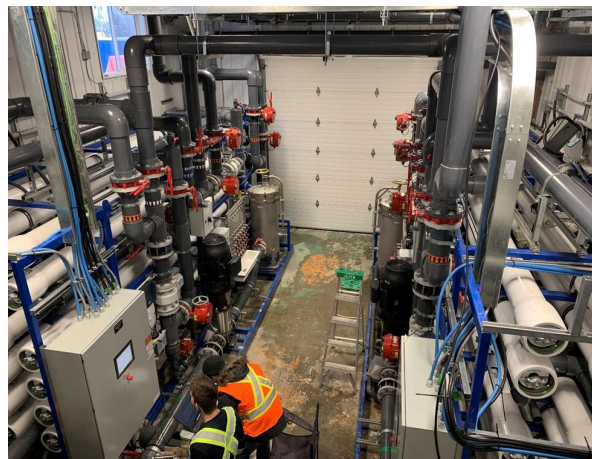
To make water have similar aesthetic characteristics to the existing source, treatment was required for Hardness, pH, Sodium, and Alkalinity.

To achieve the treatment of the water, an aerator is required to remove the Methane and Hydrogen Sulfide, and a Reverse Osmosis (RO) system required to reduce the Barium, Total Dissolved Solids and Manganese to below the allowable limits. The RO also reduces the hardness, sodium, and alkalinity to be similar to the river water.

Where are we at now?

The Aquifer water test results were shared with the community in a well attended open house on April 18, 2019. Engineering consultants were in attendance and handled community questions and concerns. After a good discussion it was decided to move forward with the Aquifer Water Source.

In December 2019, two 10-inch diameter production wells were drilled near the existing treatment plant. The wells are located in a secure aquifer and each well is capable of producing up to 500 usgpm or 31.5 L/s.

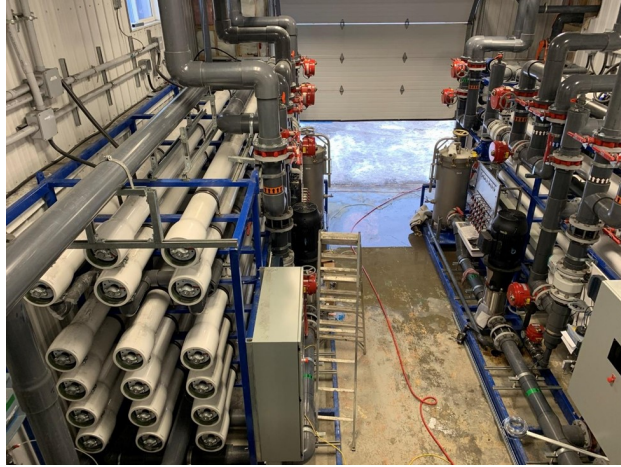


In February 2020, a Design-Build Contractor was chosen to take conceptual design through to detailed design and to construct the system. The Design-Build Contractor is now in the final stages of commissioning the system.

Water Quality Tests confirm that the water entering the distribution system conforms to all Canadian Drinking Water Quality Guidelines and Northern Health's Water Quality Guideline for all Mandatory Allowable Concentrations. There are some aesthetic water quality concerns that are being monitored, and contingency plans are being developed should the concerns about taste and smell persist.

Where are we going?

Just because the water treatment plant is producing water for Hudson's Hope, doesn't mean that the work is finished. To protect the public, the district will continue to perform bi-weekly bacteriological testing of the raw water, treated water, and multiple points throughout the distribution system. To monitor for water parameters that could affect health over the long term, the District will continue to perform annual testing of chemical and physical properties of the water. If at any point there is an indication that water quality has changed, additional testing will be performed to ensure the water is safe.



The aesthetic qualities of the water are also very important. The aesthetic properties of the water are much more difficult to identify since taste and odour can be quite subjective. During the commissioning, some residents in the distribution system reported less than desirable water quality issues. These concerns were received and documented, but since commissioning was ongoing it was too early to make changes to the treatment process. Now that the system is close to completion, the water quality should be consistent, and if you have any comments about the water please email the Chief Administrative Officer of the District at cao@hudsonshope.ca or call the District Office at 250-783-9901 and as best you can, please describe what you are noticing with the water and your location in town. Should issues persist, changes will be made to address identifiable issues.

For the Water Treatment Plant Project, the Design-Build Contractor has a two-year warranty period where they are responsible for the integrity of the system components. In addition to the two-year warranty period, there is a prorated ten-year membrane replacement in the event that the membranes require replacement before ten years.

How is Enhanced Care changing commercial auto insurance?



Enhanced Care is designed to make auto insurance more affordable and accessible for British Columbians. This means that there will be changes to coverages which all customers, including **Commercial Fleet** and **Non-Fleet** customers, will need to be aware of.



The new auto insurance model is designed to **improve affordability** by removing legal costs from the system.



The Enhanced Care model intends to **reverse the projected upward cost** for bodily injury claims, which has put pressure on insurance premiums for policy holders.

Key Coverage Changes

The points below highlight the key coverage changes that will come in to effect under Enhanced Care on May 01, 2021

Pre May 01, 2021



Third party insurance is purchased to protect the insured against liability for losses or damage the insured causes to another individual or their property.



If your driver causes a crash, Basic insurance pays when the other person makes a claim against your policy for their injuries or damage to their vehicle or property.



Litigation can be pursued against other parties for damage caused to their vehicle and to cover expenses related to injuries that have been incurred.



If your vehicle is hit by an unidentified motorist, your vehicle is eligible for coverage even if your policy doesn't have optional coverage through a statutory Hit and Run coverage.

Post May 01, 2021



The policyholder obtains first party insurance to cover losses or damage to the policyholder's vehicles, property or themselves.



If your driver is in a crash in BC, their injury claims are covered under Enhanced Care and Basic insurance pays for vehicle damage to the extent your driver is not at fault.



Litigation can be pursued against some other parties for certain damage if their actions may have contributed to the crash, for example damage to personal property, downtime or environmental clean-up.



The Hit and Run statutory coverage will no longer exist for vehicle damage and an optional product will be needed to cover this exposure.



More Information



Basic Vehicle Damage coverage

Basic Vehicle Damage coverage will be included in Basic mandatory coverage and will cover your vehicle damage in crashes where you are not at fault.

The cost of repairs or replacement of a vehicle is covered up to a limit of **\$200,000** and is included in Basic policies at no additional cost to the extent that your driver is not at fault for the crash.





Collision coverage will provide coverage when your driver is at fault and for costs of repair or replacement of a vehicle above this limit.

Your discount is not impacted by hit and run claims where your collision coverage is used, or if your driver is not at fault and Basic Vehicle Damage coverage is used to pay for damage.

Basic Third Party Liability

Legal action will not be necessary for most crashes in BC due to the significantly enhanced accident benefits available with Enhanced Care coverage and as most BC drivers whose vehicles are damaged by another vehicle will be able to access Basic Vehicle Damage coverage.



Third party liability will still be required in some circumstances, if your driver causes:

- Damage to someone else's vehicle or causes injury **while driving outside of BC**,
- Damage to property, other than a vehicle, while driving (hit a building or a fence), or
- Damage to the contents inside the other driver's vehicle.

Basic Third Party Liability under Enhanced Care will continue to provide up to \$200,000 in Third Party Liability coverage. Optional Extended Third Party Liability coverage will still be available.

Hit and Run coverage



Starting May 1, 2021, vehicle damage coverage from a hit and run changes from a Basic coverage to an **Optional coverage**.

This change means all policyholders will no longer subsidize coverage for hit and run incidents, making premiums fairer. It also makes BC's coverage for hit and run consistent with most other jurisdictions across Canada.

If your policy already includes collision coverage, you will be covered for hit and run claims. All British Columbians, regardless of whether they have any insurance coverage, will be covered for any injuries resulting from a hit and run, under Enhanced Accident Benefits.

RECYCLING PLASTIC CONTAINERS

Plastic is recycled into new packaging, broodloom, rope, brush bristles, car bumpers, household furnishings, decking, picnic tables, deck chairs and gardening supplies.



Accepted Materials

- Plastic jugs with screw tops used for milk, cooking oil, laundry detergent and fabric softener, cleaning solutions, cleaning products, body care products, windshield washer fluid, etc.
- Plastic bottles with screw caps, spray pump, or pull-up tops for food, dish soap, mouthwash, shampoos, conditioners and other personal care products, pills and vitamins, laundry products, etc.
- Plastic jars with wide mouths and screw-top lids for peanut butter, jam, nuts, condiments, vitamins and supplements, personal care products, etc.
- Plastic packaging for cannabis product
- Plastic clamshells with hinged or click-closed tops for baked goods, fruit, produce, eggs, etc.
- Plastic black-bottom trays and clear tops for deli chicken, single-serve meals, prepared foods, baked goods, housewares, and hardware such as screws or picture hangers, etc.
- Plastic tubs and lids for food such as margarine and spreads, dairy products such as yogurt, cottage cheese, sour cream, ice cream, etc.
- Plastic cold drink cups with lids for take-out beverages



Not Accepted

- Containers for motor oil, vehicle lubricant or antifreeze products (call the RCBC Hotline 1-800-667-4321 or check [Recyclepedia](#))
- Packaging labelled biodegradable or compostable

Accepted Materials Cont'd

- Plastic garden pots and trays for bedding plants, seedlings, vegetable plants, etc.
- Plastic pails less than 25L for laundry detergent, ice cream, pet food, etc.
- Microwavable bowls and cups
- Empty single-use coffee and tea pods; remove lids and do not include lids with recycling
- Rigid plastic packaging for toys, toothbrushes, batteries, etc; remove paper backing and recycle separately

- Liquid-absorbing pads, e.g., in trays of meat, poultry, fish, etc.
- Plastic wrap
- Plastic blister packs e.g. plastic/foil protective packaging for chewing gum and pills
- Ceramic plant pots
- Lawn edging, tarps, plastic furniture or toys
- Garden hoses
- Plastic string or rope
- Plastic paint cans (call the RCBC Hotline 1-800-667-4321 or check [Recyclepedia](#))

- Pails larger than 25L
- Pails for lubricants and oils (call the RCBC Hotline 1-800-667-4321 or check [Recyclepedia](#))
- Microwavable bowls with metal rims
- Plastic or foil lids from coffee and tea pods
- Beverage bottles or jugs for flavoured tea, juice, or other beverages can be returned to depot for deposit refund or included in container recycling





Police Report February / March 2021



Hudson's Hope RCMP responded to 30 calls for service between February 22nd and March 21st. 68 written violations and warning tickets were issued to drivers between the above dates with 34 of those violations being speeding in the school zone along Beattie Drive. Highway and road safety continues to be a big focus for the Hudson's Hope RCMP with the school zone along Beattie Drive and the various construction zones along Hwy 29 being the chief focus for traffic enforcement at this time.

Please make note of the numerous construction sites along Hwy 29 toward Fort St. John. Due to the increase of work sites along the highway, there is a large fluctuation between the speed zones for each site. Police will be monitoring these zones as they are a posted construction site and fines will range from \$196.00 to \$253.00 for speeding violations within a marked construction zone.

On February 28th, the Hudson's Hope RCMP received a report of a break & enter plus theft from a worksite along the Kobes Creek FSR. Several items including a red 2020 Polaris side x side and thousands of dollars worth of tools had been stolen from within the building. Police are currently working several leads on this file and the investigation currently remains on-going.

On March 4th, the Hudson's Hope RCMP were conducting speed enforcement in the school zone along Beattie Drive when a commercial truck, loaded with a large over-sized structure, was observed travelling through the zone and at one point, the load caught an over-hanging commercial line, resulting in the line snapping. This truck was stopped and upon CVSE attending and conducting an inspection, it was found that the load was not within the regulations according to their transport permits resulting in the driver and the company being issued a fine.

On March 5th, the Hudson's Hope RCMP were advised to a commercial truck that had been travelling along Beattie Drive which was observed pulling down yet another over-hanging commercial line due to the height of the load being transported. Police located and stopped the truck, which was confirmed to be from the same company from that of the incident the day prior. CVSE attended and upon an inspection being conducted, it was found that the load met the legal height restrictions, however it was believed that due to the over-height truck passing through the day prior, several of the commercial lines along Beattie Drive may have been stretched. Associated companies were notified to have all lines repaired.

On March 18th, the Hudson's Hope RCMP was conducting traffic enforcement along

Beattie Drive with police monitoring motorists for distracted driving violations. Several drivers were stopped and issued fines for the use of an electronic device while operating a motor vehicle. This violation comes with a fine of \$368.00 and 4 points to your licence.

As a note, distracted driving is not just the use of a cellular device but can encompass anything that takes your attention away from driving. The use of a cell phone for the purpose of the GPS feature is still defined as "Use an Electronic Device while Driving", though this is something that police find drivers conducting often. We all play a part in making our roads safe, so when you're behind the wheel, we ask that the focus be on the road.

Also, do not tape your activated cellular phone to your steering wheel and call it "Hands Free", as one still texts and uses said cellular device. Daily fact: When your cellphone screen dips left or right while making turns after it's taped to the steering wheel of your vehicle, your head will follow. True story!

Over the past several months, the Hudson's Hope RCMP have been receiving several complaints for possible Covid-19 regulation violations for both individuals and local businesses. The RCMP have been working alongside the other Provincial agencies who also govern and enforce the regulations and fines regarding all Covid-19 related matters within the province. With each complaint received, a detailed investigation is completed and those individuals and business have been issued warnings and/ or fines with on-going monitoring by Provincial agencies.

The Importance of a 9-1-1 Address

Distracted Driving and the Law:

According to section 214.2 of the Motor Vehicle Act, a driver cannot operate a hand-held electronic device (including hand-held cellphones, smartphones, tablets and other electronic hand-held devices such as music players, GPS Navigation Systems, etc.). Also, a driver cannot communicate using text messages or email on any type of electronic device. Drivers in the Graduated Licensing Program, (GLP) are restricted from using hands-free cellphones while driving. Drivers with a regular licence are permitted to use hands-free cellphones and devices that can be operated with one touch or voice command, provided that the device is securely fixed to the vehicle or worn securely on the driver's body.

Any driver caught texting, emailing, holding a cellphone or other hand-held electronic device while driving will be fined \$368 and receive four driver penalty points (total \$543 minimum).

GLP Drivers

GLP drivers who receive one ticket will have their license reviewed by the Superintendent and may face driving prohibitions. Fully licensed drivers who receive two tickets in a year will have their license reviewed by the Superintendent and face possible three to six months prohibition. In addition to the suspension, two tickets in one year will cost you \$1,256 (two fines at \$368 each, plus eight penalty points at \$520) and if you have points from other tickets (e.g. speeding), it will cost you even more.

PROTECTIVE SERVICES

SPRING BURNING

As the weather starts to warm up many folks are beginning to plan some spring-time cleanup activities including the removal of yard waste and debris. Please remember that under the Fire Protection & Life Safety Bylaw 775 which was adopted in 2010, no person shall light or start an open air fire within the District without first having obtained a Burning Permit from the Fire Chief or his designate. These permits are available at the District Office and can be issued for a onetime event or for an extended period of up to one year.

The only time a permit is not required is during the following situations:

- Burning refuse or garden waste only in an incinerator covered with a screen to prevent flying sparks and is approved by the Fire Chief
- The cooking of food using a portable barbeque apparatus
- Burning on privately owned lands or in developed campgrounds where fireplaces, stoves, and/or fire pits are provided and approved by the Fire Chief
- Burning by the Fire & Rescue Services for the purposes of training

If you are contemplating an open burn:

- Consider your options to compost, recycle, or haul the material to the Hudson's Hope Transfer Site.
- Be a good neighbour. Burn only when it will not affect the health and welfare of the community.
- Call the BC Ministry of Environment to check the ventilation index at **1-888-281-2992**. The index must be "good" for the day of the burn and "fair" or "good" for the second day of the burn.
- Check the wind conditions. If the wind is strong enough to carry sparks and embers to other combustible materials postpone your burn.

Remember that your burn must comply with the Environmental Management Act and the Open Burning Smoke Control Regulation as well as the British Columbia Wildfire Act.

Homeowner Information to Building Permits

The District of Hudson's Hope wants to assist homeowners and contractors to avoid unnecessary delays and expense in planning and construction of residential projects. Below explains when permits are required, requirements for the permit, possible other documents that may be required and other information to assist you in obtaining your building permit. Additional information is available at the District Office or online at www.hudsonshope.ca

A BUILDING PERMIT IS REQUIRED TO:

- construct a new home;
- locate mobile / modular home;
- construct a commercial, industrial or public use building;
- construct a new accessory building e.g., carport, farm building, garage or storage shed;
- renovate existing buildings;
- undertake any structural work such as interior partitions;
- enclose a porch or roof over a sundeck;
- move or demolish a building;
- re-roof a building;
- reconstruct after damage;
- plumbing system changes;

INFORMATION TO BE SUBMITTED WITH A BUILDING PERMIT APPLICATION

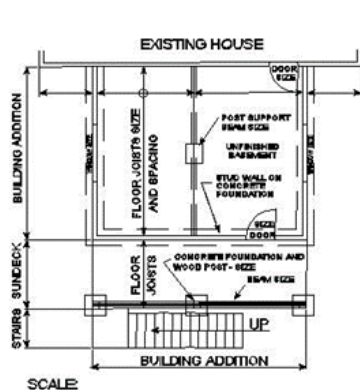
The following items must be supplied along with a completed Building Permit Application before a Building Permit can be issued. A Building Permit fee is based on the value of the building or structure and will be calculated by the Building Official.

1. BUILDING PLANS

Two sets of detailed building plans. If you cannot draw the necessary building or site plans, then you should obtain the services of a qualified person.

Example Floor Plans

- scale not less than 1:50 metric (1/4 inch to 1 foot);
- size and location of windows and doors;
- location of all plumbing fixtures;
- location of all mechanical equipment.
- all rooms, size and use of each;
- all dimensions;
- finished and unfinished areas; —

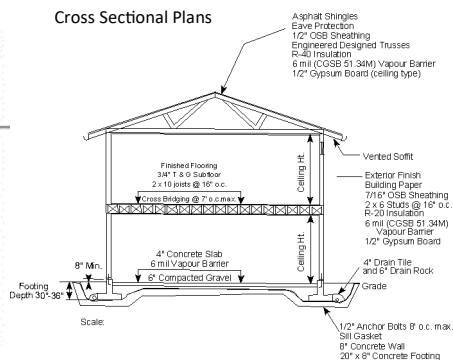

Cross Sectional Plans



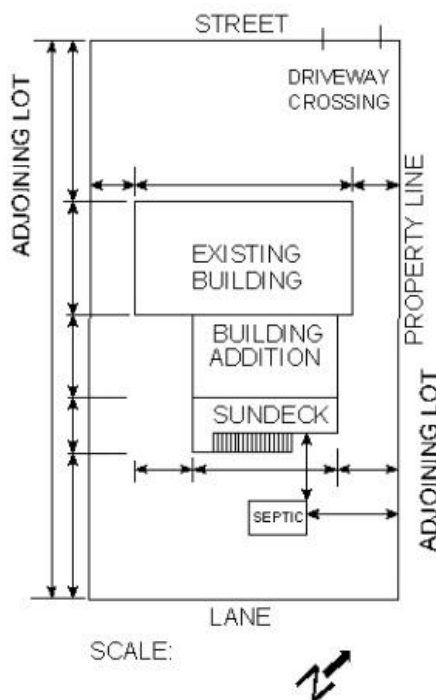

2. SITE PLAN

- full legal description of lot: lot number, plan number; district lot number (from your tax notice or Title);
- lot dimensions;
- adjoining street names;
- locations and uses of existing and proposed buildings or additions;
- distances from all property lines for existing and proposed buildings or additions;
- location of legal road access to the property;
- size, location and number of parking spaces;
- existing and proposed wells or other water sources;
- location of existing or proposed sewage disposal fields on property;
- location of any watercourses on property showing distances from existing or proposed buildings or additions;

This information is intended to assist the general public in applying for a Building Permit within the District of Hudson's Hope.



BUILDING INSPECTIONS (Typical)

The Building Bylaw requires inspections at the following stages of construction;

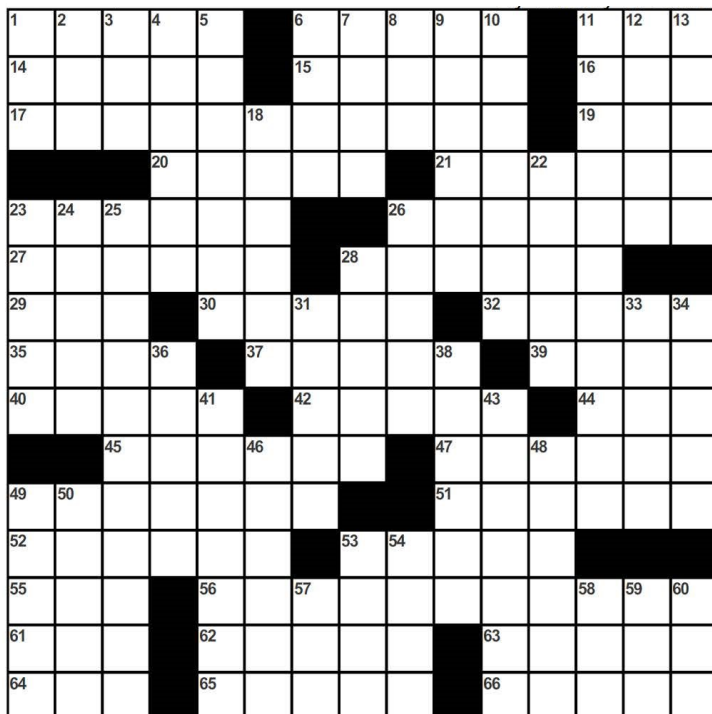
- Footings - prior to pouring concrete.
- Backfilling - after completion of damp-proofing, drain tile, and drain rock (if required), but prior to backfilling.
- Plumbing - before any part of the plumbing system is covered.
- Framing - after the entire rough-in plumbing, electrical and mechanical equipment is installed and the framing is completed to lockup stage, but prior to insulating.
- Insulation and Vapour Barrier - after all insulation and vapour barriers are installed, but prior to covering.
- Final - when the building or portion thereof is completed and ready for occupancy, but prior to occupancy thereof.

An Occupancy Certificate is required prior to occupancy of a building. In order for an Occupancy Certificate to be issued, all inspections above must be approved.

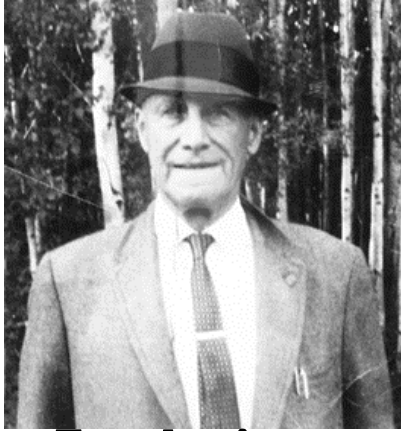

April at the Hudson's Hope Museum

Have you ever wondered about the pioneers that came to Hudson's Hope in the early days? Have you wondered why? Or what brought them? In Hudson's Hope many of the pioneers both men and women, that came to the area to settle, farm, trap or as traders.



Tom Jamieson

Tom Jamieson was a BC Provincial Police officer, stationed in Fort St John (in 1910-11), who on patrol had visited Hudson's Hope and envisioned it as a beautiful townsite. In 1912, Jamieson led a group which included Mackie Smith, Dr. Fredette and the Landry Brothers overland from Edmonton. They left Edmonton on February 14th of 1912. Along the way they added to their party, Dudley Shaw, Fred Monteith and Bill Carter, all joining them on the journey. The journey was very muddy, and they had to struggle with their team of horses and sleigh, but eventually they arrived in Hudson's Hope on March 29, 1912. Over the coming months the land was surveyed, and Jamieson's group claimed property along the river on either side of the HBC trading post building houses and starting to farm and trap.

Summer Student Needed: The museum is now accepting applications for our Summer Student positions. The museum is looking for a Digitization Assistant and a Curator Assistant.

Job Descriptions: Collate artifact documentation to complete an inventory of artifacts on display in exhibition areas and outdoor cabins. Upload data onto database and photography – training is provided. Some accessioning will be necessary, guiding tours, working in the gift shop, and daily cleaning. **Applicant must be a full-time student, who is returning to school in the fall.** Please send or drop off resume to the museum before April 25th, 2021. These positions are open to high school students but due to the YCW Grant Funding, students must be 16 or older.

The museum is always looking for volunteers! If you have a keen interest in history or would just like to learn a little more about the valley we live in, come out and volunteer – we have lots of scanning and accessioning of historical photos and artifacts to be done – training is provided.

Kindness matters – Letter from Captain Keith Gale.

Hello!

My name is Padre (Captain) Keith Gale, and I am the chaplain for the international NATO mission to keep Latvia free. There are about 1500 soldiers from 10 different NATO countries deployed to Latvia, but perhaps the most interesting thing about this mission is that it is Canadian led. All the other countries here look to Canadian leadership to ensure it remains successful. This is a testament to the excellent training and ability of our amazing Canadian soldiers.

Our mission here is very complex and sensitive because of the political history of the Baltic countries. Communications are restricted – we cannot take photos or post on social media about the mission, a part of the new digital nature of modern conflicts. Latvia has rarely had independence historically, and many of their occupiers have been cruel. For example, they have endured multiple mass-deportations. The largest was in 1949, when over 10% of the Latvian population (about 120,000 people) was deported by Stalin, with many families being separated. A typical situation would have seen fathers deported to Siberia and mothers deported with their children to Ukraine. Many would not survive the harsh work conditions, and most families never saw each other again. This year marks 30 years of independence, which is the first time in Latvian history a whole generation has experienced independent rule over their own country. You can see why it is so important to Latvians that they have international partners such as Canada to ensure they remain independent and free.

Latvia is a beautiful country with a wonderful and determined people. Although the country is quite small – there are fewer than two million residents and in an area about the same size as New Brunswick – they have their own distinct language. It is not a dialect of Russian as I assumed before being deployed here. Latvian is the most archaic Indo-European language still spoken. A third of Latvians live in the capital Riga, the largest city in the Baltics. We are stationed in Ādaži, which is about 24 km north of Riga.

Because of the COVID situation, most of our soldiers have not been able to travel, and many have not even left the base except to train. Our mid-tour breaks had to be cancelled. This has meant six straight months without getting to visit our families. For us, December was near the end of the tour and the time when COVID was hitting Latvia the hardest. Also, because Latvia is further north, there was only 6.5 hours of daylight each day – compare this to 9 hours for southern Canada. The weather here is not as cold as Canada, but it is very wet and overcast almost every day at this time of year.

We received a lot of mail from wonderful people back in Canada like you. You have no idea what it meant that you remembered and support us. It really made our holiday season to receive your cards and gifts. This year, the outpouring of support was truly remarkable. We are humbled and renewed by your support. THANK YOU for your kindness, your thoughtfulness, and your generosity. You were a ray of sunshine at a dark and gloomy time, right when we needed it! We may not have been able to visit our families, but your gifts reminded us that the larger Canadian family was right here with us. Although we could not be physically home, we were still there in your hearts.

I hope this letter finds you well. By the time you receive it, we will be back in Canada and there will be a new rotation of soldiers in place for another six months. Please continue to remember our troops; your support shows the true generous spirit of Canada and helps us to continue to fight for a better world.

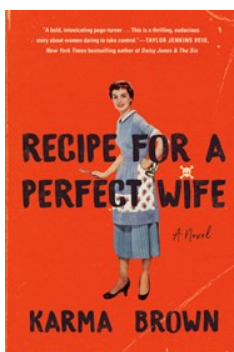

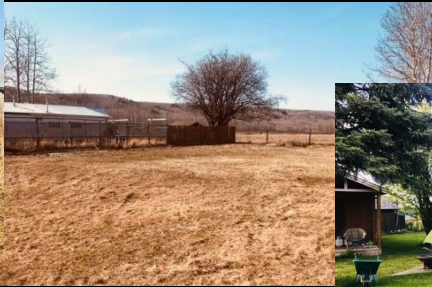

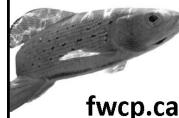
