HIT AND RUN VEHICLE DAMAGE COVERAGE

DISCUSSION GUIDE

Introduction to Hit and Run

Under Enhanced Care, hit and run vehicle damage coverage is moving from a statutory insurance coverage to an Optional coverage. The hit and run statutory coverage will only be available to cover non-vehicle property damage (e.g. a broken fence caused by a vehicle colliding with it). Starting May 1, 2021 a small number of customers who **do not have Collision coverage** may be faced with a coverage gap if they suffer a hit and run loss. Because customers may be caught unaware of this coverage gap, **ICBC is offering a transition period** to help our customers with this change.



CURRENTLY

Hit and run vehicle damage is covered by:

ICBC Collision coverage

- Subject to a \$750 deductible

Statutory provision

- For vehicles that do not carry Collision coverage
- Subject to a \$750 deductible
- All policyholders pay into the statutory provision through their Basic insurance premiums

Collision through a private insurer



UNDER ENHANCED CARE

- The statutory provision for vehicle damage and injury/death will be discontinued on May 1, 2021
- Injury/death will be covered by **Enhanced Accident Benefits**
- **Non-vehicle property damage** will continue to be covered by the statutory provision
- Collision will continue to cover vehicle damages from a hit and run and the Collision deductible will apply (i.e. no longer capped at \$750)
- A lower cost **Optional Hit and Run** product will be offered



What is the one-time provision?

Customers who have not purchased Collision prior to May 1, 2021 may experience an **unexpected coverage gap for hit and run losses**. Because this change will come as a surprise to many customers, ICBC is offering a transition solution for customers as a **one-time provision**, subject to a \$750 deductible, if a customer reports a valid hit and run claim after May 1, 2021 and they do not have Collision coverage through ICBC or a private insurer. The provision will remain in place until **April 30, 2022**, and will apply only if the first post-May 1 renewal has not happened yet; this gives customers the **opportunity to discuss their coverage options with their broker**.



A new **Optional Hit and Run coverage for vehicle damage** will be offered on the APV250 for customers to purchase as of May 1, 2021. This Optional coverage will be at a lower rate than ICBC's Collision coverage, giving customers options to protect themselves against crashes involving an unidentified driver.

Why are we offering optional Hit and Run coverage?

- 1 This will make B.C.'s coverage for hit and run consistent with most other jurisdictions across Canada, where hit and run coverage is purchased through Optional insurance.
- 2 The change means that all policyholders will no longer subsidize a statutory coverage for hit and run vehicle damages – making premiums fairer and ensuring that drivers who pay for hit and run vehicle damage coverage are the ones who benefit.

Top Frequently Asked Questions

Q1: Why is ICBC moving away from the statutory provision?

A: This shift makes premiums fairer by ensuring that drivers who pay for hit and run coverage are the ones who benefit from it. Today, all policyholders pay for a statutory hit and run coverage through their Basic insurance premiums. The statutory provision will continue to fund unidentified non-vehicle property damage post May 1, 2021.

Q2: Will there be a deductible for the hit and run one-time provision?

A: Yes, the one-time provision will cover the cost of the loss subject to a \$750 deductible.

Q3: Won't my Basic Vehicle Damage coverage cover hit and run claims if I'm not responsible?

A: Basic Vehicle Damage Coverage will only cover customers where we have identified the responsible driver. Basic Vehicle Damage coverage specifically excludes hit and run damage claims, for which customers will need Optional coverage. Hit and run coverage will continue to be included as part of ICBC's Collision coverage, which most customers already purchase, or it can be purchased as a new Optional coverage, at a lower-cost than Collision coverage, that will specifically cover vehicle damage caused by a hit and run.

Q4: How long will the transition period be?

A: The transition period will be from May 1, 2021 to April 30, 2022. However, each customer will only be eligible for the goodwill provision once, provided they have not renewed their insurance.

Q5: If I have purchased Collision coverage from ICBC prior to May 1st 2021, will I be eligible for the hit and run one-time provision?

A: No. Collision coverage will continue to provide protection for hit and run losses for customers. However, those customers with ICBC Collision with a deductible exceeding \$750 will see their deductible capped at \$750 for their first hit and run incident during the transition period.



OPEN FIRE REGULATIONS

CAMPFIRES, CATEGORY 2 FIRES AND CATEGORY 3 FIRES: WHAT'S THE DIFFERENCE?



CAMPFIRE:

- Any fire smaller than 0.5 metres high by 0.5 metres wide

REGULATIONS:



You must have ready access to 8 litres of water or a shovel for the entire time your campfire is lit.




Your campfire must be completely extinguished and the ashes must be cool to the touch before leaving the area for any length of time. (Hot coals can reignite the fire.)



During campfire prohibitions, only a CSA- or ULC-approved portable campfire apparatus may be used, and the flame height must not exceed 15 centimetres.



You must build a fire guard around your campfire.



CATEGORY 2 FIRE:

- 1 to 2 concurrently burning piles no larger than 2 metres high by 3 metres wide
- Stubble or grass burning over an area less than 0.2 hectares

REGULATIONS:



A fuel break must be established around any Category 2 burn area.



Fireworks are banned when a Category 2 fire prohibition is in effect.



Burning barrels are banned when a Category 2 fire prohibition is in effect.



At least one person equipped with a fire-fighting hand tool must monitor the fire at all times.



CATEGORY 3 FIRE:

- Any fire larger than 2 metres high by 3 metres wide
- 3 or more concurrently burning piles no larger than 2 metres high by 3 metres wide
- 1 or more burning windrows
- Stubble or grass burning over an area greater than 0.2 hectares

REGULATIONS:



A fuel break must be established around any Category 3 burn area.



Monitor your open burn to ensure that the fire doesn't spread beyond its intended size.



You must have a burn registration number to light a Category 3 open fire. Call the burn registration line 1 888 797-1717 to obtain one.

GENERAL REGULATIONS:



Never burn in strong wind conditions.



Your fire must be extinguished before leaving the area.



Always keep your fire a safe distance away from nearby branches, wood and other combustible materials.



Do not conduct Category 2 or Category 3 burns when venting conditions are "Poor" or "Fair". Always check here first: www.bcairquality.ca/readings/ventilation-index.html

*Further bans and restrictions can be implemented at the BC Wildfire Service's discretion.



Anyone found in contravention of an open fire prohibition may be fined up to \$1,150. If your fire escapes and results in a wildfire, you may be fined anywhere from \$100,000 to \$1 million and be sentenced to one year in prison. Please check with local government authorities for any other restrictions before lighting any open fire.

OFF-HIGHWAY THIRD PARTY LIABILITY

DISCUSSION GUIDE



Introduction to Off-Highway Third Party Liability for non-standard vehicles

Under Enhanced Care, licensed non-standard vehicles like golf carts in rate class 030, farm tractors in rate class 100 and industrial vehicles in rate class 170 will no longer have access to **ICBC's Basic and Extension Third Party Liability coverage** when used or operated off-highway, except those insured under a Garage Certificate (APV4). This change applies to all new and renew policies effective May 1, 2021. This will leave the owners of certain non-standard vehicles vulnerable to being sued, with no Third Party Liability coverage. In order to address this vulnerability, ICBC is introducing a new optional coverage, **Off-Highway Third Party Liability**, on the APV250.

What is Off-Highway Third Party Liability?



For our customers with licensed golf carts, utility vehicles, farm tractors and industrial vehicles (**rate classes 030, 100 and 170**), who operate off-highway (e.g. on logging roads or private land), **Off-highway Third Party Liability** will protect them in the event of an off-highway crash they are responsible for.

Off Highway Third Party Liability coverage is available in limits of **\$200K, \$1M, \$2M, \$3M and \$5M**.



There will be a **transition period** as the change in Basic Third Party liability exclusion does not apply to all certificates effective May 1, 2021. Any policy effective prior to **May 1, 2021** that includes **Basic Third Party Liability** will **retain** the off-highway coverage until the expiry date of the **policy**.

OFF-HIGHWAY THIRD PARTY LIABILITY

These changes do not impact the existing Third Party Liability coverage included in the **APV261** and **APV119** policies. These products will continue to exist and be offered on those vehicles that are eligible for them.



CURRENTLY

Basic and Extension Third Party Liability currently provide coverage for:

- Damages arising out of use or operation of a vehicle both on and off highway
- Does not make a distinction between **standard and non-standard vehicles** or **on vs. off highway crashes**



For customer who purchase **\$1M, \$2M, \$3M or \$5M** in Off-Highway Third Party Liability coverage, brokers will follow a manual process to add this coverage to the APV250. For details, visit **Autoplan Procedures**.

Why are we offering Off-Highway Third Party Liability?

Most crashes in B.C. happen on-highway and involve standard vehicles. Moving coverage for off-highway crashes involving non-standard vehicles to an Optional coverage means that only those policy holders who need and use this coverage are paying for it - making premiums more fair.

Optional Off-Highway Third Party Liability will ensure that the small subset of customers have the coverage they need when operating non-standard vehicles off-highway.

Off-Highway Third Party Liability Scenario



Lars is operating an excavator at a private residence that his construction company is renovating. The excavator is insured with ICBC's APV250 policy under rate class 170 and licensed with an X-plate. He misjudges the space he has available and crashes into the property owners vehicle which is parked in the driveway. Because the crash took place in a private driveway and involved a utility vehicle (rate class 170 Lars' **Off-Highway Third Party Liability coverage** for \$1M responds.



UNDER ENHANCED CARE

- Under Enhanced Care, there will be a limitation on lawsuits relating to injury/death and vehicle damage for most crashes in B.C. involving standard vehicles.
- The limitation on lawsuits will **not apply to off-highway** crashes involving **non-standard** vehicles
- **Basic and Extension Third Party Liability** will not cover off-highway crash involving non-standard vehicles
- This will only impact a small number of customers as the majority of vehicles on the road are standard vehicles

What is the difference between on-highway and off-highway?

It is a highway if:

- It is intended for or used by the general public for the passage of vehicles, regardless of who owns or maintains the road.

It is NOT a highway if:

- It is a private road or parking lot not used by the public or clearly designated by sign or gate to deter public use.
- It is an industrial road, a forest service road, or a petroleum development road.

- Off road vehicles (ORVs), golf carts, industrial machines, utility vehicles, and farm tractors are all examples of non-standard vehicles in rate classes 030, 100, and 170.
- Standard vehicles include cars, motorcycles, busses, trucks, and motorhomes.

Top Frequently Asked Questions

Q1: Will there be different limits available for Off-Highway Third Party Liability?

A: The optional Off-Highway Third Party Liability policy is available with a \$200k, \$1M, \$2M, \$3M and \$5M limit.

Q2: Will Basic Third Party Liability exclude non-standard vehicle accidents off-highway effective May 1, 2021?

A: Basic and Extension Third Party Liability policies effective May 1, 2021 or later will exclude this scenario. However, there will be a transition period in which any Basic and Extension Third Party Liability policies issued prior to May 1, 2021 will continue to cover these losses until the policy expires or is cancelled. Basic Third Party Liability in a Garage Certificate (APV4) is not affected by this change.

Q3: How is this different from the APV261 and APV119 policies?

A: The new Off-Highway Third Party Liability coverage is meant to provide coverage for customers whose non-standard vehicles do not meet the eligibility criteria for the APV261 (e.g. meet requirements for Farm Fleet and Industrial fleet conditional licence) or the APV119 (e.g. ATV, golf carts in rate class 036). These products will continue to be offered for those customers who meet the eligibility requirements.

Q5: Will customers be able to sue for injury for those accidents involving non-standard vehicles off-highway?

A: Yes, customers would be able to sue for injury in these situations where they are not at-fault. Underinsured Motorist Protection will also apply in an off-highway crash involving a cyclist or pedestrian is struck by a non-standard vehicle that doesn't have enough coverage.

Q6: Why is a manual process required to add the higher limits (\$1M to \$5M) to the APV250?

A: The decision to include additional limits of \$1M, \$2M, \$3M, and \$5M was made following feedback from commercial customers and brokers. As this decision to include these limits was made after Enhanced Care technical requirements were in place, a manual process will be leveraged until PolicyCenter changes are in place. This process ensures that those customers who wish to have the higher limit will be covered in the event of a crash.

ATTENTION HOME OWNERS

BASIC GRANT

Applicant under 65 years of age.

If the current year tax is less than \$1120, the basic N & R home owner grant is the amount of the current year taxes less \$350. If the current year tax is \$1120 or more, the basic N & R home owner grant is \$770. The minimum tax payment required from applicants under 65 is \$350.

ADDITIONAL GRANT

Applicant 65 years of age or older or in receipt of prescribed war veterans or disability allowances, or persons with disabilities as defined under the regulations.

If the current year tax is less than \$1145, the basic

N & R home owner grant, inclusive of the additional grant, is the amount of the current year tax less \$100.

If the current year tax is \$1145 or more, the basic N & R home owner grant, inclusive of the additional grant is \$1045.

The minimum tax payment required from applicants under this heading is \$100.

Assessed values above \$1,625,000.

Above \$1,625,000 of residential assessed value, the grant will be reduced on a graduated scale. That is, the grant otherwise payable is to be reduced by \$5 for every \$1,000 of residential assessed value in excess of \$1,625,000.

Police Report March /April 2021



Hudson's Hope RCMP responded to 44 calls for service between March 21st and April 18th. 84 written violations and warning tickets were issued to drivers between the above dates with 44 of those violations being speeding in the school zone along Beattie Drive. Highway and road safety continues to be a big focus for the Hudson's Hope RCMP with the school zone along Beattie Drive and the various construction zones along Hwy 29 being the chief focus for traffic enforcement at this time.

Between the above dates, the Hudson's Hope RCMP issued 5 excessive speeding tickets to drivers, 4 of which were stopped in the Beattie Dr. 30km/hr school zone. These tickets are issued when a driver is found to be 43km/hr over the posted speed limit and come with a \$368.00 fine, 3 points to one's license, and a 7 day impound of the stopped vehicle. The tow bill and storage fees are the responsibility of the registered owner.

Please make note of the numerous construction sites along Hwy 29 toward Fort St. John. Due to the increase of work sites along the highway, there is a large fluctuation between the speed zones for each site. Police will be monitoring these zones as they are a posted construction site and fines will range from \$196.00 to \$253.00 for speeding violations within a marked construction zone.

On March 22nd, the Hudson's Hope RCMP conducted a routine traffic check-stop along Hwy 29. During the check-stop, approximately 60 drivers were stopped and police checked for sobriety, valid driver's licenses and vehicle registrations. Several violation tickets were issued to drivers this day.

On March 23rd, the Hudson's Hope RCMP attempted to stop a speeding vehicle which the driver refused to stop and attempted to flee from police. The vehicle was later located and blocked in on Hwy 97 with 2x suspects attempting to flee on foot but later apprehended by RCMP. The two occupants were identified and later charged with several criminal code and motor vehicle offences.

As they say, "Mounties always get their man"

Between April 6th to 9th, the Hudson's Hope RCMP responded to 3 different motor vehicle collisions with 2 of them being on Canyon Dr. and the 3rd on the Farrell Creek Rd. No major injuries were incurred between the three incidents but speed and weather conditions were deemed a factor in all three incidents.

On April 12th, the Hudson's Hope RCMP were advised of a spreading wildfire along Hwy 29 near Farrell Creek Rd. The fire was found to be approximately 4.5 hectares

in size and started due to a small camp fire that had gotten away from the individuals. No public or private property was damaged and the BC Wildfires crew was able to contain and later extinguish the fire.

This is a good reminder that we are rolling into the “Wildfire Season” and for persons to seek out and educate themselves on what the current fire status is in our area before conducting bonfires or yard burns. Persons can seek this information by contacting your local Fire Department or by looking up the current statuses on the BC Wildfire web pages.

On April 16th, the Hudson’s Hope RCMP received a report of 2x persons who had been out snowmobiling on the Williston Lake, and found themselves hitting thin ice (literally), when their sleds broke through the ice and became submerged. The two persons were able to crawl/swim as they broke through the ice several times while attempting to make it to shore. Luckily, one of the persons was able to grab a small bag from the back of one of the sinking sleds prior to crawling/swimming to shore. This bag contained food, fire starter, and an Inreach GPS system that allowed the two to send out a distress message, as well as start a fire to stay warm and dry off. Given the remote location the two found themselves in, Search and Rescue was called out and upon a rescue attempt by land, it was found that the ice was too thin to make it to the two stranded persons. Upon daylight the following day, the Search and Rescue helicopter was able to locate the two individuals and transport them to safety with no injuries.

This is a good reminder to double check the ice on our lakes and rivers prior to adventuring out on them. Having a survival kit packed is essential when exploring our vast lands. This can mean the difference between experiencing a very cold or semi-comfortable night if one is to find themselves stranded or lost. Items such as emergency blankets, matches, non-perishable foods, compass, and if possible, a GPS system of some sorts are good items to have packed. A small, sometimes forgotten about item that can prove to be useful, is a small reflective mirror. This can be used not only to verify your handsomeness, but also can be used to reflect the sunshine to signal others in the area or a helicopter that may be in the area searching for you.



May at the Hudson's Hope Museum

Have you ever wondered about the pioneers that came to Hudson's Hope in the early days? Have you wondered why? Or what brought them? In Hudson's Hope many of the pioneers, men and women that came to the area came to settle, farm, trap or as traders.

Edith and Melvin Kylo. Edith came to Hudson's Hope in 1929 to work as the Teacher for the community and Mel arrived in 1930 to set up a barbershop in town. Sadly, the small town did not need a barber, so Mel tried his hand at gold panning and farming. Later in his life, Mel worked as a Judge for the Small Claims Court, as the coroner, and he was a councilman for Hudson's Hope. Edith taught on and off at the school and raised four boys (Ken, Glenn, David and Martin) in a small log cabin (that Mel built) on the edge of town! Edith was very involved in helping to collect and record life as a pioneer in the area and was very involved in starting the Hudson's Hope Historical Society. She also wrote the Hudson's Hope Section of The Peacemakers and worked as the curator at the museum for many years!





